1.º TERMO ADITIVO DE PRAZO E VALOR AO CONTRATO N.º 16/2022 DE PRESTAÇÃO DE SERVIÇOS DE INFORMÁTICA, celebrado entre o Conselho Regional de Engenharia, Arquitetura e Agronomia do Estado do Amazonas – CREA-AM e a EYES NWHERE SISTEMAS INTELIGENTES DE IMAGENS LTDA, na forma abaixo:

CONTRATANTE: CONSELHO REGIONAL DE ENGENHARIA E AGRONOMIA DO ESTADO DO AMAZONAS – CREA-AM, entidade de fiscalização do exercício profissional instituído pela Lei Federal n.º 5.194/66, inscrito no CNPJ sob o n.º 04.322.541/0001.97, com sede na Rua Costa Azevedo, n.º174 – Centro – Manaus-AM, doravante designado simplesmente **CONTRATANTE**, neste ato representado por sua Presidente Eng. Pesca **ALZIRA MIRANDA DE OLIVEIRA**, brasileira, solteira, inscrita no CREA-AM sob o n.º 041***50 e CPF n.º 606.***.***-20, residente e domiciliada na cidade de Manaus/AM, de acordo com as atribuições conferidas pelo art. 93, incisos I, III e XX do Regimento Interno do CREA-AM.

CONTRATADA: EYES NWHERE SISTEMAS INTELIGENTES DE IMAGENS LTDA, inscrita no CNPJ. n.º 07.244.008/0002-23, com endereço na Av. Efigênio Salles, n.º 711, Parque Dez de Novembro, CEP 69.055-736, Manaus-AM, tel. 92/3131-3388, doravante denominada simplesmente **CONTRATADA**, neste ato representado por seu representante legal, Diretor operacional **Sr. CARLOS EDUARDO MORAES LIMA**, já qualificado no Contrato, e tem entre si ajustado o presente termo, que se irá se reger com a forma descrita abaixo:

CLÁUSULA PRIMEIRA: DA VIGÊNCIA – O presente Termo Aditivo tem por objetivo a prorrogação de prazo, por mais **12 (doze) meses** do referido contrato, a contar de **11/04/2025 A 10/04/2026**, conforme a cláusula décima primeira do Contrato.

CLÁUSULA SEGUNDA: DO VALOR – O valor global do contrato passará de R\$ 24.000,00 (vinte e quatro mil reais), equivalentes a R\$ 2.000,00 (dois mil reais) mensais, para R\$ 30.000,00 (trinta mil reais), correspondentes a R\$ 2.500,00 (dois mil e quinhentos reais) mensais, em razão do upgrade de velocidade contratado. A **CONTRATADA** compromete-se a **manter o valor mensal de R\$ 2.500,00 (dois mil e quinhentos reais) na eventual prorrogação por mais 12 (doze) meses após o término da presente vigência**, caso haja interesse da **CONTRATANTE** em renovar o contrato, não sendo aplicado qualquer reajuste no período subsequente.

CLÁUSULA TERCEIRA: DA ESPECIFICAÇÃO DO OBJETO – O objeto contratado, fornecimento de link de dados para acesso à Internet de forma dedicada, com velocidade de 100MB, **passará a 200 Mbps**, fato este que justifica o acréscimo de valor.

CLÁUSULA QUARTA: DA RATIFICAÇÃO – Ficam integralmente ratificadas as demais cláusulas do contrato original que, expressa ou implicitamente, não conflitem com as disposições deste Termo.


